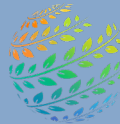

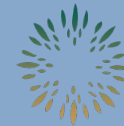

Community Markets for Conservation – A Pre-Due Diligence Assessment by TIFS

Founded in 2000

Location: Zambia

Scale: 230,000 farmers

Natural Capital:

- Chemical free production through agroforestry, compost use, crop rotation and organic fertilizers
- Sustainable land management on 168,800 ha
- 1,540M ha forest protected, worth USD34M; carbon credits sold USD2,6M

Social Capital:

- 84 community-run cooperatives with over USD1.7M annually for local extension services
- 182 savings and loans groups to support entrepreneurial ventures by women
- Cookstoves and wood from agroforestry save women up to 193 labor hours per year
- Farm talk radio reaches 1.2M households

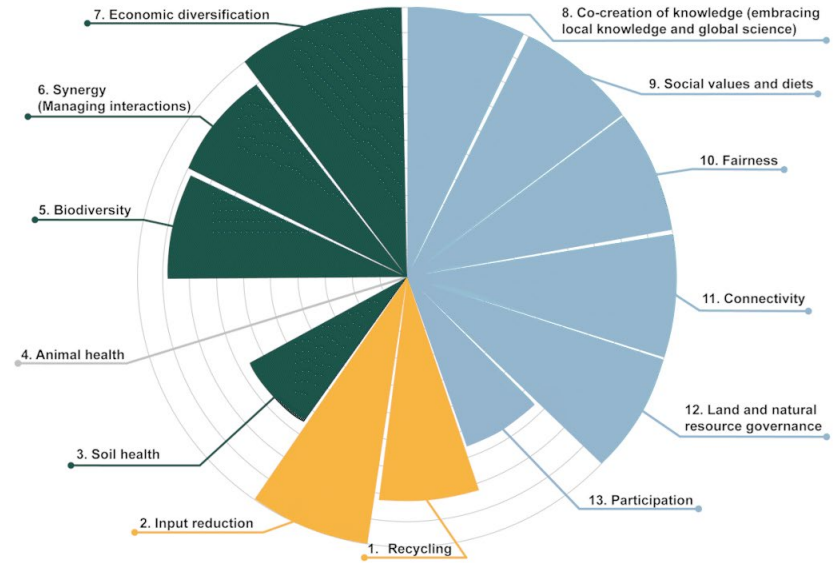
Human Capital:

- Nearly 100% increase in food security

Produced Capital:

- 6 different natural, nutritious food products developed in 5 processing centers that employ over 290 Zambians
- Tripled annual income for COMACO farmers

Amplifying Within

Capitalizing better on existing opportunities, stabilizing, professionalizing and/or speeding up.

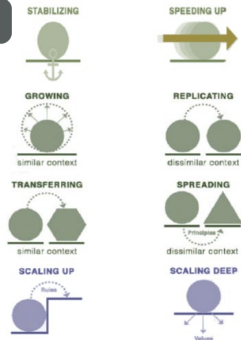
Amplifying Out

Growing in scale, replicating or starting new commercial activities in other contexts.

Amplifying Beyond

Changing values and norms
Advocating, lobbying for-, networking for-, or supporting the discourse of agroecology and attempting to codify the impact into law, policy, or institutions.
